cCBOD	= \$1,106.00 per 1,000 pounds of excess CBOD
cTSS	= \$1,099.68 per 1,000 pounds of excess TSS

OUTSIDE

cCBOD	= \$1,935.51 per 1,000 pounds of excess CBOD
cTSS	= \$1,924.44 per 1,000 pounds of excess TSS
